

RESOLUTION NO 1030

RESOLUTION OF THE BOARD OF PUBLIC UTILITIES WAIVING COMPETITIVE BIDDING AND AUTHORIZING A SOLE SOURCE BLANKET PURCHASE ORDER FOR REMOTE AND STANDARD-READ WATER METERS, PARTS, AND ANTENNAS, AND APPROVING ADDITIONAL FUNDS FOR CURRENT BLANKET PURCHASE ORDER TO SENSUS METERING SYSTEMS, PITTSBURG, PENNSYLVANIA

WHEREAS, the City has a requirement for remote and standard-read type water meters parts, and antennas; and

WHEREAS, City staff has found it more cost effective and efficient to standardize on a single brand of equipment, Sensus, rather than stock, install, and maintain multiple brands of water meters and parts; and

WHEREAS, Sensus Metering Systems has submitted a one-year fixed price proposal to provide remote and standard-read type water meters, parts, and antennas; and

WHEREAS, City staff has thoroughly analyzed the proposal submitted by Sensus Metering Systems, and considers the offered price for the remote and standard-read type water meters parts, and antennas fair and reasonable, and recommends it would be in the City's best interests to accept; and

WHEREAS, City staff requests authorization of additional funds for the current blanket purchase order to Sensus Metering Systems through the term of October 31, 2012; and

WHEREAS, the Board of Public Utilities has considered the report of City staff and has concluded that the proposal submitted by Sensus Metering Systems is fair and reasonable, and determines it would be in the City's best interests to accept.

NOW, THEREFORE, BE IT RESOLVED that the Board of Public Utilities waives competitive bidding and authorizes the award of a sole source blanket purchase order for remote and standard-read type water meters, parts, and antennas to Sensus Metering Systems, Pittsburg Pennsylvania, in an amount not to exceed \$400,000, and approves additional funds for the current blanket purchase order to Sensus Metering Systems not to exceed \$250,000.

BE IT FURTHER RESOLVED that the Board of Public Utilities authorizes the Chief Financial Officer to pay all claims for this purchase out of the stores inventory GL Key 001100-1301.

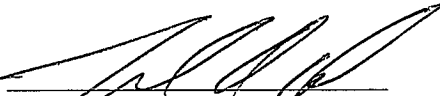

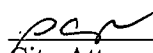
