City's Investment Objectives

- Investment Objectives: In accordance with the City's Investment Policy, the City's primary objectives in order of priority are:
 - Safety Safety of principal is the foremost objective of the investment program. Investments for the City will be made in a manner that seeks to ensure the preservation of capital in the overall portfolio.
 - Liquidity The City's investment portfolio will remain sufficiently liquid to enable the City to meet
 all operating requirements which might be reasonably anticipated.
 - Yield The City's investment portfolio shall be designed with the objective of attaining a market rate of return throughout budgetary and economic cycles, taking into account the investment risk constraints, liquidity needs, and cash flow characteristics of the portfolio.
- Certification: The City has sufficient funds to meet expenditures for the following six-month period.

Investment Guidelines

• The City invests in permitted securities consistent with California Government Code sections §§53601, 53635, and 16429.1. The City's Investment Policy includes additional sector allocation and maturity restrictions that reflect the City's risk tolerances.

Market Summary

Economic Conditions

- The second estimate of the third quarter U.S. GDP growth was raised to 2.1% from 1.9%. The report highlighted continued reliance on the American consumer as consumer spending accounted for nearly all the growth. Government spending and housing were also positive contributors, while business investment detracted.
- The U.S. economy added 266,000 jobs in November far exceeding expectations as the labor market resumed strength post the GM strike. There were notable gains in health care, professional and technical services, and manufacturing. The unemployment rate fell to 3.5% while wage growth remained tepid, holding steady at 3.1% over the past 12 months.
- U.S. manufacturing activity had mixed results for the month of November. The ISM manufacturing index fell to 48.1, indicating a slowdown for the fourth consecutive month. New orders also deteriorated. However, a similar index by Markit diverged, actually rising to 52.6, marking the best showing since April 2019. While both surveys tell slightly different stories, it is clear that U.S.-China trade tensions continued to weigh on confidence and business decisions.
- U.S equities posted solid gains, reaching new record highs in November, despite the expected decline in third quarter corporate earnings. While better than analysts' expectations, third quarter earnings per share marked the first year-overyear decline since 2016. Over the month, the S&P 500 advanced 3.6%, the Dow Jones climbed 4.1%, and the NASDAQ rose 4.6%.

Market Reaction

- The U.S. Treasury yield curve moved higher over the month, with 2-10 year maturities up 9 to 13 basis points (0.09% to 0.13%). A stable Fed, abundant liquidity, and reduced trade risks stabilized the U.S. rate outlook.
- The general move higher in rates caused shorter-term Treasuries to outperform their longer-dated counterparts. For the month, the 3-month and 2-year Constant Maturity U.S. Treasury Index returned 0.13% and -0.06%, respectively. Meanwhile, the 10-year and 30-year indices generated total returns of -0.76% and -0.44%, respectively.
- Supply and demand technical factors remain supportive of most non-government spread sectors, which continue to perform well.








