



Report a Private Property Weed Abatement Compliance Issue

Submitted complaint forms must meet the criteria listed below and will be considered after Fire Department inspectors conduct the initial scheduled citywide inspections during fire season

Weed Abatement Ordinance Criteria:

Complaints regarding weed abatement compliance on private property within the Santa Rosa City limits will be considered by the Fire Department if the parcel being reported meets any of the following Weed Abatement Ordinance criteria:

- The parcel is a developed lot over .5 acres with over .5 acres of unimproved land
- The parcel is an undeveloped/ vacant lot*
- The parcels is located within the www.srcity.org/WUI*

*Vacant parcels within the City limits and all parcels in the 2017 wildfire rebuild areas are already scheduled for annual inspection by the Fire Department, and complaints do not need to be filed for these properties. Learn more about this at srcity.org/WeedAbatement.

Please Note:

- A number of properties bordering a highway, freeway, or offramp are the responsibility of Caltrans. Visit Caltrans website to submit a request at csr.dot.ca.gov
- A residential property, not located in the Wildland Urban Interface (WUI) area, with overgrown lawn or overgrown weeds in the sidewalk (or a sidewalk or median along public streets overgrown with weeds), should not be submitted to the Weed Abatement program. Instead, visit srcity.org/MySantaRosa; follow the prompts to submit your complaint which will be directed to the appropriate department.
- Live vines, or live trees are not considered a fire hazard and do not meet the criteria for submittal to the Weed Abatement Program.
- City parks are scheduled to be abated and maintained throughout the fire season on an annual basis; complaints do not need to be filed for these areas. For information on how City properties are prioritized for weed abatement, visit srcity.org/WeedAbatement.
